MINUTES of FULL COUNCIL ORDINARY BUSINESS MEETING on Tuesday 24th October 2017, 7.30pm at Churchstoke Community Hall

**P*/2017/1076: CCC supports the application and would like to add the following comments for consideration:

- a) CCC notes the size of the development and the potential impact on facilities in the village, so asks that if consent is granted that a S106 agreement for funding to enhance recreation facilities for the community is an integral part of planning conditions
- b) CCC notes that part of the proposed development is outside the development boundary allocated for housing in the UDP, and therefore as it a departure from planning policy CCC assumes that the application will be called to Planning Committee for decision.

*AGRI/2017/0076: CCC objects to the application for the following reasons:

- a) Unacceptable proximity of the proposed business premises to the adjacent domestic dwelling
- b) Loss of visual and lighting amenity for the adjacent domestic dwelling
- c) Alternatives sites exist nearby for such a proposed business premises, which will have less adverse impact on the adjacent domestic dwelling.

*P/2017/1148: CCC notes that the application as an extension to a previous barn conversion, but is unsure whether an extension to barn a conversion is permitted within planning policy. CCC would be of a mind to support the application if it falls within such policy.
