***22/1702/FUL: CCC expresses disappointment that despite having being granted, by planning officers on 16th Nov'22, a response deadline extension until 23rd Dec'22, the application was determined two days before on 21st Dec'22. CCC appreciates the statutory deadline pressures on planning officers and is always grateful for their flexibility where practicable but on this occasion is disappointed by events. CCC asks that this comment is posted against the application so that members of the public can see that the community council endeavoured to do its duty but has been frustrated by decisions elsewhere.*

**22/1829/FUL: CCC notes the application and the comments by CPAT which illustrates TAN 24 (May 2017) where archaeological remains are considered likely to exist, and a study has not already been undertaken by the applicant, the local planning authority should ask an applicant to undertake a desk-based archaeological assessment and, where appropriate, an archaeological evaluation. There appears to be no such assessment, so CCC asks that no decision is made until one is undertaken and then consulted upon.*
