- *in the interests of avoiding ambiguity or conjecture, to communicate to CCC, Churchstoke CP School, and parents exactly and what is intended, when and where*
- *if removal of free transport is intended, to work together with Shropshire Council to find a solution in the interests of pupils and to avoid possible consequential decline of Churchstoke CP School and the community.*

The Chair referred members to the consultation. The Clerk reminded Members that the last formal Open Spaces Assessment was 2018 although CCC has responded to the LDP Settlement Profiles and Community Aspirations in September 2024 to indicate,

- Aspirations in terms of public open spaces, sports and play provision should be to retain

- Informal Open Spaces: there are amenity green space at The Courthouse (a registered village green), at Cross Likely and at Belle Vue. Although these may be smaller than 0.2 hectare, the community council is if the view these should be included in some way.

**RESOLVED**

*CCC confirms the updated draft Open Spaces Assessment and re-iterates from its response to LDP Preferred Strategy (Sep'24) the importance of including in some way the open spaces at The Courthouse (a registered village green), at Cross Likey, and at Belle Vue, and wishes to add open space at North Walk (a registered village green) to the list.*

*\*25/0306/FUL: CCC objects to the application for the following reasons,*

- a) Highways safety: the community council is of the view that the entrance onto the busy 60mph limit 'C' class road, which is the main link between the two main settlements in the community a popular route to Shrewsbury, is adjacent to a curve in the road already with restricted visibility. The community council is of the opinion that that heavy vehicular traffic using the entrance to service the lagoon will present an additional unacceptable hazard to other road users*
- b) Scale and environmental regulation: the community council of the view that the size of the lagoon appears to be disproportionately large compared to the size of the adjacent fields so asks that the applicant seeks and heeds advice on this matter from environmental regulatory authorities*
- c) Odour and visual amenity: the community council considers the lagoon and operations from it are likely to generate foul odour impacting on the nearby area and on the natural environmental beauty and amenity of the area which is also forms part of the local and tourism asset of the area*
- d) Water and environment: the lagoon is in an elevated position. The community council is of the opinion this presents an unacceptable risk of downward seepage to small water courses and then into the River Camlad*
- e) Lack of visual screening*
- f) Lack of evidence of how the development would enhance biodiversity and the environment and protect open countryside*
- g) Loss of hedgerow habitat appears to be excessive.*

The Clerk reported further on telephone conversations with a county council highways officer who confirms that there is no official bus-stop at the Co-op and it will not be providing a shelter at a drivers' discretionary pick-up drop-off site. Members recalled the presence of a bus-stop signpost at the Co-op and that it features on bus timetables.

### **RESOLVED**

*CCC writes to the highways authority to ask for written confirmation that there is no official bus-stop at the Co-op and it will not be providing a shelter at a drivers' discretionary pick-up drop-off site, even though there is a bus-stop signpost installed at the Co-op and that it features on current bus timetables and on the proposed timetables in the recent Powys Local Bus Network consultation as 'Churchstoke Shopping Centre', and will consider the matter further in due course.*
